



GENERAL CONDITIONS – 2010 TRIPS

Rates: All airfares included in the package rates are based on special group fares and require that passengers travel on the days offered in the itinerary. Airfares can be reserved from any city of origin at the lowest rates. Air and Land Prices may change due to currency fluctuations and fuel surcharges.

Reservations and Payments: A completed tour application together with a deposit of \$500.00 per person must be received before confirming your reservations. Final payment must be received by August 31, 2008. Final Documents will only be sent once full and final payment has been received.

Cancellations: Airline tickets are nonrefundable once ticketed. All cancellations must be in writing (e-mail is sufficient). In addition to the airline ticketing cost, a \$500 per person cancellation fee will be charged if received 90 days or more prior to departure, plus any and all other non-refundable costs incurred. Cancellations received 90 to 61 days prior to departure are subject to a \$750 per person charge, plus any and all other non-refundable costs incurred. Cancellations made within 60 days prior to departure are non-refundable and any outstanding balance is due to Marathon Adventures. Once airline tickets are booked, the full balance is due to Marathon Adventures, regardless of if or when you submit a cancellation notice.

Not included in price: All items not specifically listed under tour features.

Insurance: Trip cancellation, baggage, health and accident insurance is available on request and is highly recommended to all participants.

Responsibility: These tours are operated by Marathon Adventures, LLC. of Minneapolis, MN who acts only as an agent for the passenger to the companies offering such services and assumes no liability for injury, damage, loss, accident, delay or irregularity caused by any reason whatsoever by any party offering such services. The right is reserved to cancel the tour prior to departure with a full refund made as full settlement to the passenger. Marathon Adventures, LLC. may make any changes or alterations in the itinerary as it deems necessary for the proper handling of the tour and may refuse any person as a member of the tour. The sole responsibility of any airline used is limited to that set out in the passenger contract evidenced by the ticket.
